1. Premise

The National Recruitment Portal was created with the aim of accelerating the process of modernization and renewal of the country by supporting the Office for competitions and recruitment of the Department of the Public Service in the implementation of the new public recruitment system. The project aims to speed up, simplify and digitise the organisational processes of recruitment procedures in public administrations in order to reduce their economic and social costs.

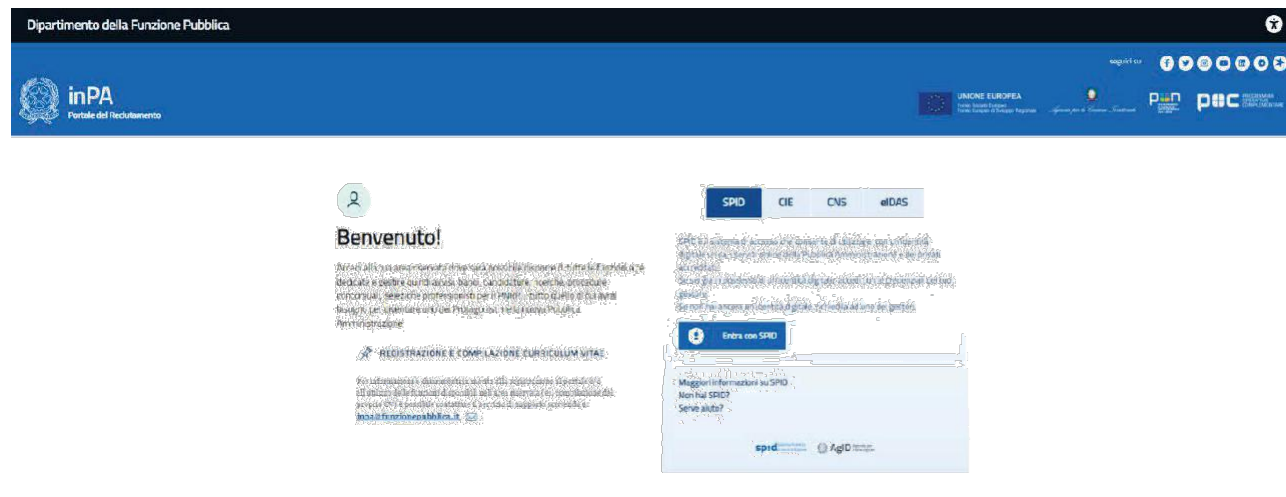
2. Access to the platform

The user, who wishes to submit his application, can access the Recruitment Portal via the following link: <https://www.inpa.gov.it>/passing the "Login to personal area " button located in the upper right corner of the home page.



Access to the Portal may be made through:

- SPID (Public Digital Identity System);
- Smartcard, using the CNS (National Services Card);
- CIE (Electronic Identity Card)
- eldAS

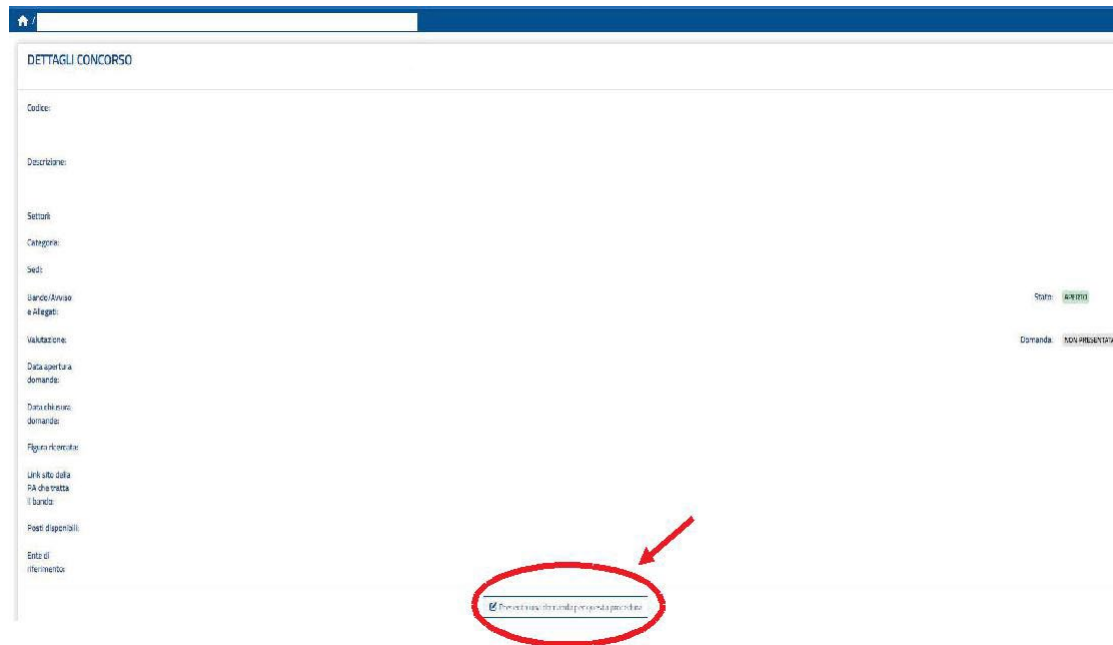


Once logged in, through the "Contest" button it is possible to search for the notice related to the procedure to which the user intends to submit his application.

Typing in the field "Search" the keyword "Albertina" will display the list of competitions organized by the Institute. The user must then select the relevant warning.

The "Details of the competition" screen summarises all the information relating to the call (e.g. deadline for submission of applications) and its annexes (e.g. call, minutes of installation of the selection board, ranking list etc.).

The "Apply for this procedure" button allows you to complete your application:



3. Filling in the application

In order to submit your application, you must complete all the sections on the left side of the screen. These will be correctly filled out when all sections are "checked". In the "CHECK AND SUBMIT" section you can continue with the submission of the application or you can cancel the application.

If the fields are not filled in correctly or have errors, they will be highlighted with a  **WARNING symbol : the portal will not allow**

the closure and submission of incomplete applications and/ or without the required attachments.
